- The institution shall not charge any Capitation fee or donation for admission or other higher charges from students or their 12.

  guardians in any form.
- 13. The institution will have an independent building as per norms of the University with a separate approach.
- 14. This order shall stand cancelled in case the college fails to deposit Affiliation fee (unless specifically exempted) by the due date.
